Subject

Installation of Ruggedised Passenger Seats with Standard Cushions.

Applicability

GA8 / GA8-TC 320 Models.

Amendments

Issue 1: Initial Issue. GippsAero Reference GAE11#2723.

Background

This Service Bulletin approves the removal of the standard passenger seats and installation of the ruggedised passenger seat with the standard cushions. Since the ruggedised seat includes the comfort cushions and corresponding seat covers; Part A of this Service Bulletin provides the data to remove the seat covers and cushions from the ruggedised passenger seats. However it is possible to order already modified seats and then only Part B needs to be carried out. Note that these seats will be delivered without seat cushions or covers. If new seat cushions or covers are desired then please order separately using the GA8 IPC or applicable customer option number from the airframe logbook.

Compliance

For applicable aircraft this optional service bulletin may be incorporated at the owner's discretion.

Weight and Balance

The weight difference between the standard passenger seats with part number GA8-252011-011/012 and the ruggedised seat with standard cushions installed with part number GA8-252013-011/012 and SB-GA8-2020-203 incorporated is negligible. Note that this requires no change to the seat cover part numbers currently installed on the affected aircraft.

PART A

These parts are required to remove the comfort cushions and seat covers from a ruggesdised passenger seat. Any number of seats may be ordered.

Accomplishment Instructions:

PART A – SEAT CONVERSION

- 1.1. Remove the seat back cover with part number GEN100618-GA-01-04/03 as applicable from the ruggedised passenger seat with part number GA8-252013-011/012 (items 1 or 2) if fitted.
- 1.2. Remove the seat back cushion with part number GEN100618-GA-02-02 from the ruggedised passenger seat from the previous step, if fitted.
- 1.3. Remove the seat bottom cushion and cover with part numbers GEN100618-GA-02-01 or GA8-252020-011 and GEN100618-GA-01-01 from the ruggedised passenger seat from the previous step, if fitted.
- 1.4. Repeat all steps for each ruggedised seat that requires conversion in preparation for Part B of this Service Bulletin.

PART B – INSTALLATION

- 2.1. Remove the standard passenger seats with part numbers GA8-252011-011/012 in accordance with the GA8 Service Manual section 25-20-01 from the locations in the aircraft that the ruggedised seats will be installed.
- 2.2. Remove the existing back and bottom seat covers from the standard passenger seats.
- 2.3. Remove the standard back and bottom cushions with part number GA8-251022-021 and GA8-251022-023 from the standard seats.
- 2.4. Install the standard back and bottom cushions with part number GA8-251022-021 and GA8-251022-023 into the ruggedised seat with no cushions and no covers, part numbers GA8-252013-011/012 and SB-GA8-2020-203 Part A (items 3 or 4).
- 2.5. Install the existing back and bottom seat covers onto the ruggedised passenger seats with standard cushions from the previous step.
- 2.6. Install the ruggedised passenger seats from the previous step in accordance with the GA8 Service Manual section 25-20-01 into the desired locations.

Documentation

The maintenance log of the affected aircraft must be updated to reflect incorporation of this Service Bulletin. If not all the passenger seats were converted from standard to ruggedised then the entry must identify which seat rows and which side (left/right) has been modified.
