## SUBJECT: NOMAD SERVICE BULLETIN NMD-32-13 REVISION 1

Ladies and Gentlemen,

Service Bulletin NMD-32-13 (Reference No. 114) is now issued at Revision 1 incorporating the following changes:

(1) Page 1, Reference No.114 amended to No.132
 Para 1A(1) - Aircraft Affected
 Line 3 - 'Revision 1' added after S/B number

Page 1, Para 1D - Compliance - Paragraph amended to read: - It is recommended that this service bulletin be incorporated, at the operators discretion, at the next overhaul of the main landing gear oleo leg or if leakage develops between the oleo plunger and the stub axle mounting block. If the aircraft is not operating in a cold environment and/or no oil leakage has occurred it is not necessary to implement this modification.

- (2) Page 2, Para 2 The following preamble added: 'For main gear oleo legs which have to be removed for servicing or scheduled maintenance, rework the lower cap assembly in accordance with the instructions in Sub-para's A to K. For legs installed in aircraft carry out the instructions detailed in Sub-para's L to N.
- (3) Page 3, Para 2B (4)
  Line 1 Sentence amended to read: 'Invert the leg, drain off and dispose of all the fluid:

Line 2 - 'the cap from the tube.' added to the end of the sentence. Page 3. para 2E(2)

Line 1 - !0.2105 + 0.0025! amended to '0.240 + 0.005!

Line 2 - '2.145' amended to '2.134'

Page 3, Para 2E(4)

Sentence amended to read - 'Re-identify the lower cap and oleo assembly by adding Service Bulletin No NMD-32-13 adjacent to component Part No's.
