Service Letter

SUBJECT:

Foreign Approval of increased Maximum Landing Weight (MLW) for aircraft with Increased Gross Weight (IGW)

APPLICABILITY:

GA8 model aircraft with SB-GA8-2011-66 Part A incorporated and Part B is applicable.

GA8-TC 320 model aircraft with SB-GA8-2011-65 Part A incorporated and Part B is applicable.

AMENDMENTS:

Issue 1: Initial issue.

Issue 2: Authorisation status updated. Ref. GAE12#2376.

Issue 3: EASA and TC Authorisation for GA8-TC 320 Model. Ref GAE12#2466.

BACKGROUND:

This Service Letter identifies NAA jurisdictions that authorise operation of an increased MLW of 1860 kg (4100 lb) for applicable GA8 and/or GA8-TC 320 aircraft that incorporate the IGW modification.

NOTE:

GA8 and/or GA8-TC 320 model aircraft and with applicability noted against Part B as set out in Table 2 of Service Bulletin.

The increased MLW of 1860 kg (4100 lb) has been approved by the Civil Aviation Safety Authority (CASA) of Australia for GA8 and GA8-TC 320 model aircraft with IGW. The performance information for a MLW of 1860 kg (4100 lb) has been inserted into the new flight manual supplements.

Other National Airworthiness Authorities (NAAs) require individual acceptance of major modifications. Therefore operators of GA8 and/or GA8-TC 320 aircraft that incorporate the IGW modification must consult this Service Letter prior to conducting operations with a MLW over 1814 kg (4000 lb)

Approved maximum landing weight can be found in the applicable Type Certificate Data Sheet issued by the relevant NAA
