Background:

Service experience has shown that movement of the mufflers can result in fretting damage to the nose leg support braces, firewall shield or engine mount frame. The replacement exhaust support strap locates the muffler more rigidly but allows for adequate vibration dampening.

This Service Bulletin must be incorporated at next scheduled maintenance.


